Individual Income Taxes

The first U.S. income tax was passed in 1861 to help finance the Civil War. In 1894, the Supreme Court, in *Pollock v. Farmers' Loan and Trust Co.*, held that an early version of the individual income tax was unconstitutional. In response to this Supreme Court decision, a constitutional amendment was passed to authorize the individual income tax.
